DBS:

Ladies and gentlemen welcome welcome welcome to the French connection's Thursdays edition on the eleven day of May 2006. My name is Darryl Bradford Smith and it's great to have you here on another broadcast of this this most important of shows, The French Connection. iamthewitness.com is the website and iamthewitnesses@hotmail.com is the connection to me.....

... and we also work on many other subjects as you also know, but this particular subject has a lot of twists and turns ... my guest today ... is Christopher Bollyn,... has looked into many of the anomalies that 9/11 has brought forward...

CB:

... Yeah we have, we talked about Stewart Air Force Base and the security at Logan airport and lack of security...

DBS:

What was the airfield's contract with... what Israeli company was working out of Logan?

CB::

That was a company called Huntley USA Corporation, which is a wholly owned subsidiary of a company formerly known as International Consultants on Targeted Security, or ICTS, which is a Mossad company or base of Israelis who have long careers in Israeli military intelligence, and they base their company for international, providing security at airports, they are based out of Amsterdam Holland.

DBS:

oh they are in Schiphol airport, they are also in Gatwick from what I understand and they have other airports in America don't they, including the one we are going to discuss today over in Cleveland'?

CB:

Well that's a good question, but Cleveland, I haven't checked that. But they were, they did provide airport security at Newark, at Newark airport

and also Boston Logan on 9/11, they provide security at a lot of airports. That's interesting, I haven't looked into that about the Cleveland airport yet.

DBS:

Well what we do know is that there were some very strange behaviors of these of these aircraft that kind of converged over Stewart, we're going to revisit this for second because I'd like to use this this particular anomaly to bring us into the next one. Ah we have those Logan flights criss-crossing over the Stewart Air Force Base didn't we?

CB:

Yeah they converged, both flight 175 and flight 11, the two planes that hit the World Trade Center, they converged over Stewart Air Force Base, former Stewart Air Force Base, now its Stewart International Airport, and it is the only privately owned airport in the United States.

And this is only sixty miles north of the World Trade Center, so this is all within the New York metro area, and what may have happened is that these two planes, if we use the operation Northwoods scenario, these two planes may have landed at Stewart International Airport, which is in Westchester county, and drones may have taken up their flight paths, and continued the flights to the World Trade Center.

DBS:

That's not a big leap of faith, and in fact weren't there some people instrumental in in the privatization from the Port Authority of the World Trade Center and Stewart Air Force Base over the same character ...

CB:

... very good point very good point, the person behind the privatization of Stewart Air Force Base and World Trade Center, the architect of all this is **Ronald Louder** and he's he's a son of Estee Lauder, the big cosmetics company in New York, and was the director of the governor's privatization board, and he pushed for the privatization of the World Trade Center, and of this airfield in year two thousand and the airfield Stewart Air Force Base was privatized earlier than the World Trade Center, as you know the World Trade Center only actually became privatized, privately held property, on July twenty sixth of 2001, and the person that was in charge of the Port Authority of New York and New Jersey at the time was **Louis Eisenberg**, he's the former head of United Jewish Appeal, and is the person who oversaw the negotiations which delivered the lease, the ninety nine year lease into the hands and **Larry**

DBS:

Now it's interesting to note Mr. Silverstein, prior to his ownership of that building was a strip bar owner over in Brooklyn at a place called Runway 99. Now, how a man goes from owning strip clubs, to being in charge of several billion dollar buildings is anybody's guess, but but I would say there is a lot more to that story that we need to uncover but...



CB:

He was also named in a lawsuit when which in which Bill Clinton was also named, regarding the smuggling of drugs into united states, the Meana Arkansas drug smuggling ring. There was a lawsuit brought by a former marine, which was thrown out, but in this lawsuit, Larry Silverstein was named as being involved in this drug smuggling operation.

DBS:

Well no surprises there again, and here is the interesting thing about Ron Louder, and including **Mark Rich** as well, both of these men have been hovering around the deal, and both of them have a very close connection to Herzliya, where there's a university structure for preparing people to go into the Mossad, isn't there....

CB:

Yeah, you would call it, I think you would call it Mossad University, its in Herzliya, which is where the Mossad has their headquarters, north of Tel Aviv and its called the Interdisciplinary Center, the IDC and both Mr. Rich and Mr. Lauder has donated funds to the school, and they have colleges or schools in their name.

Ronald Louder has a school for strategy and government I think it is, and Mark Rich has a school for, you know, financial transactions, and the thing is is the head of the school, the dean of the school, is a former director of the Mossad.

DBS:

Here is the interesting thing, a lot of people say the CIA is involved in all this, the CIA that, what I found over my time investigating this, the CIA is pretty much gutted these days, and it's more of a paper pushing organization, but I found that most of these relationships that go back to Mossad are done with the Department of Defense and the Pentagon, and you can see that with Feith and Libby and all the rest of them, and much of their planning with the Mossad seems to go through that organization rather than the CIA, am I correct in that?

CB:

Yeah, you're right ...and also the Department of State, and what's interesting is that what I have found, I mean I've been researching 9/11 for, since it

happened, and like on this recent story about Cleveland, I was just looking at the evidence and the people involved and there suddenly it popped up this key player, who is a very very high Zionist in the United States. His name is Sam Miller, and he is actually the father of Aaron Miller, who was the senior policy adviser on the middle east for four administrations in the Department of State, and he's the father of Aaron Miller, so it's like a very small networks of people. But what I have found at every critical juncture of 9/11, weather it's the investigations, the destruction of evidence, the mysteries at Cleveland airport, what have you, I eventually find that the person, the key person who was the gatekeeper, the person who made the key decision, is a Zionist with close ties to Israel. Now this is not a coincidence.

DBS:

It's not a coincidence that some of the facilities for these were co-leased up in Stewart and co-leased over at Cleveland, ah, to government agencies, am I wrong in saying that?

CB:

No. No. You're right. I mean in Cleveland you know, these two planes landed, one was reported to have been flight 93, which supposedly crashed and in Shanksville, but in this case, the reports are very clear that the passengers were taken off the plane and taken into that NASA Facility, and this was when the entire airport had been shut down and there in the NASA facility, these passengers were interrogated or interviewed by the FBI. Now this doesn't make any sense, if this plane just had a bomb scare and they landed the plane at Cleveland just to get people off the plane, why were they taken to a NASA facility, and why were FBI agents waiting for them there. it doesn't make a lot of sense.

DBS:

No it doesn't, and I also understand that Stewart had something rather odd at the end of its runway that was rather a building that was rather clandestinely kind of installed over there, a big hangar bay and...

CB:

What's interesting about that airport, Stewart International Airport, which is owned by of a British company that has its base in Texas, in Houston I believe, that airport was privatized like I said in 2000, in early 2000, but after it was privatized and turned over to a private company from Britain, congress voted to give it millions and millions of dollars to build a new air traffic control system, a new control tower, and new hangars. And you have to ask yourself what kind of privatization was this?

DBS:

...seems like and a sweetheart of a deal to me, well here's where we start going into the other workings here.

This plane, supposedly 93, was full of American citizens and foreign travelers, I don't know the passenger lists, but from what I understand, if they were deplaned there, or if these passengers existed at all, they had to do something with them, and so basically either they actually hit the building, which we have a lot of evidence which says that's questionable, or they had to get rid of these people after the fact, and this is a painful thought to even consider, isn't it.

CB:

Yeah.

DBS:

So where does your evidence lead, you what have you got on this story?

CB:

Well the thing is, is that Cleveland airport, Cleveland Hopkins airport, was under the control of the mayor of Cleveland, his name was Michael White, and he's a black man who was under control, this is all based on the reports from the Cleveland newspapers, because mayor White in year 2005, his right hand man, a guy named Nate Gray, his closest friend, his best man at two of his weddings, and his business associate, was convicted on thirty six counts of bribery and racketeering, and things like that, involving activities in four different cities.



Well when Nate Gray was convicted, then it became clear to the people of Cleveland that mayor White probably had the most corrupt administration in the history of Cleveland.

Now the thing is that this didn't happen by itself, this mayor became the mayor because of the financial support of Samuel Miller, who was the co-chairman of the company Four City Enterprises, which is a huge real estate company. They for example, they managed the housing projects where the US Navy people live, like Great Lakes Naval base, etcetera. And they own properties from the east coast to the west coast and all in between.

Now every week Nate Gray, the man that was convicted of thirty six counts of bribery, and the mayor, mayor White, and Sam Miller, they would have dinner at a very fancy hotel in Cleveland, and in this trial, in this grand jury case, one of the co-defendants, reveals that Grey told him that Sam Miller basically ran the mayor, and ran the city.

Now this is important, because they, mayor White, closed Cleveland airport, ordered it evacuated at ten o'clock in the morning, and all the people were told that they had to leave but not take their cars, so these people had to walk out to the highway to try and get a taxi or get a ride to town, to find a place to stay.

And this means that thousands of people were evacuated from the airport, and then at 10:45 one plane landed and shortly later another plane landed, these planes were both identified as having been sabotaged with bombs. The Associated Press reported that one of the planes was flight 93, and what's interesting is that in this very short article from Associated Press, is that the spokesperson for United Airlines confirmed to the Associated Press that this was flight 93.

This plane was disembarked, and there are some ...these stories become confused over the period of a next couple days, it appears that we're getting reports from two different planes. The other plane was Delta 1989, which notably came from Boston Logan airport, and early reports from the newspapers in Dayton and Cleveland and Akron Ohio indicate that the mayor said that this first plane landed and two hundred people were taken off the plane. And these two hundred people were taken into the NASA facility or in another report they were taken to an FAA facility.

But in any case, we have for what appears to be two planes landing at the airport, one's flight 93, one's Delta 1989, and the people are offloaded and interrogated by FBI agents in a NASA facility.

DBS:

Now, how does that square, I mean there had to be people who survived the interrogations, have any income forward.

CB:

There have been some reports, on line, from some of the people who were on Delta 1989 I believe it is, and these, there are some reports, but again these are somewhat anonymous reports you know, where the name's aren't given and things like that, so we don't have a lot of evidence as to what happened to these people, which is why I called up the mayor of Cleveland yesterday. Now it's interesting after this whole case went through and his business associate was convicted of thirty six counts of bribery, the mayor, the former mayor, mayor White, retired onto his forty five acre alpaca farm, where he raises these llamas, and that's in central Ohio, I think sixty miles south of Cleveland.

And I called him up and I asked him you know, if he could tell me anything to clarify what happened at the airport, because he's the person, he's the source of information in these articles I was talking about, he held a press conference, and he says "I'm no longer in the business of giving interviews", or something to that effect, and he basically hung up the phone.

So then I called up Sam Miller, who was you know, his supporter, and asked him what he knew about what happened at Cleveland airport that day. And you know this is a man who has enormous influence in city of Cleveland, and he told me, says "I don't know nuthin about it". He doesn't know nuthin about anything at the Cleveland airport that day, and when I asked him, well, can you tell me what kind of relationship you have with the mayor at that time, he says "what business is that of yours". And I told him I was a journalist and I'm looking into this, and he says "I don't know nuthin about it" and then he hung up the phone.



And what's interesting about Sam Miller is, he is the father of Aaron Miller, who is a state official who has basically written you know, the Oslo accords, and United States middle eastern policy for the last four administrations.

DBS:

Here is where it gets interesting okay, where you also made a little visit to Shanksville.

CB:

Yes.

DBS:

... and you discussed the, what the area residents saw that day and there were some very strange discrepancies in that any official story that you found. You want to go into some of those discoveries?...

CB:

Yeah, very very much so. You know the fundamental inconsistency with the official version is that at the crash site the hole in the ground is only about twenty feet across, and it's about five or six feet deep, and I spoke to a woman who ran up to the smoking hole, immediately after the explosion or whatever caused that hole, and she told me that it sounded like a tremendous explosion, like an atomic bomb she even said, and she was working only a few hundred meters away when that happened, but when she ran up to the hole, which she said was about twenty feet across and five feet deep, she said there was no evidence of an airplane there. There were no pieces of anything, and this is a fundamental discrepancy, I mean how can you have a large jetliner full of people and passengers and luggage and what have you, disappear into a twenty foot hole and leave no trace of itself behind?



DBS:

... not only that, after the fact they put armed, the FBI was on the site almost

immediately, and so was the FAA, and the rest of them, I mean they were already waiting for this crash to happen at that place, it seems, and what they did is cordoned off the area and put armed guards there and allowed no rescuers to go and sift through the area...

CB:

And that's what Wally Miller said, you know, he was the coroner there, and the coroner is supposed to have, In the state of Pennsylvania the coroner is supposed to have jurisdiction over the crash site, or the death site and he said that he stopped being the corner after 10 minutes because there were no bodies there.

.... and this is a fundamental discrepancy, there's no evidence, the FBI then told Wally Miller that, you know the basically said "are you going to play ball with us or not", and he had to agree to turn over the site to the FBI,

Now this is important because whatever bodies they supposedly retrieved from this crash site, the local papers reported that they recovered, that they said they had recovered ten percent of the body parts and ninety percent of the plane and from this ten percent of the body parts that they supposedly recovered, these were all taken by the FBI to the Dover Air Force Base where the DNA analysis was done, and they identified who these forty, and they identified all forty people on the plane supposedly, right?

DBS:

How could they do that without family DNA to match it to?

CB:

Well what we understand is that the FBI went to the houses of the relatives and things, and asked for DNA samples, that's the explanation is that they obtained DNA evidence from some families.

DBS:

That's an investigation yet to happen I'm sure...

Right, but then the thing is, that then they turned around and sent to Wally Miller as the coroner for Somerset county, they sent these 40 death certificates,

which he signed off on, and I called him up; I know Wally Miller, I said you know

this doesn't seem to make a lot of sense, you signed off on the death certificates of forty individuals whose bodies you never saw and when, he became very upset with that, because he really did abdicate his authority to the FBI, and what's interesting is that both Wally Miller and the local paper which never reported any of this, seem to have come into some money immediately after 9/11, because they both have made extensive renovations or built new buildings after 911, and this is a very small town.

The somerset Tribune I think it's called, has a two million dollar building they built in 2002 or 2003, and it only had a circulation of fourteen thousand readers, and this paper has never asked, interviewed any of the eye witnesses who saw these military planes flying around or who saw these or screeching missiles or heard these tremendous explosions, these people, like Lee Purball and Lena Lensbauer, were never interviewed by, or Sheila McElwee I think is her name, and who saw these the thunderbolt plane, the A10 thunderbolt screaming over her car before any explosions, so we have evidence of this military planes flying in circles, these close combat planes known as wart hogs, we have evidence of them flying around, eyewitnesses seeing these planes flying in circles around the crash site, before any crash occurred.

... and it just doesn't make any sense, but because this paper did not interview any of these witnesses, and there are scores of them, they apparently did the right thing and came into a lot of money.

DBS:

Now let's talk about the FBI for a moment, it seems to be the police authority that is most corrupted in all these investigations, if you go back to looking into Oklahoma City, if you go back and look at Bill Clinton's Meana, and you look at all the machinations in Washington DC over the last twenty years, it seems like the FBI is the one most corrupted...

CB:

There's no question about it, and I think that that occurred at the top, you know the Department of Justice has had a cabal of very powerful Zionists running it,

Going back thirty years or so, there was Abraham Sofier going back into the Reagan administration time I think it was, and during Bush, Bush father's period, and now we had during the time of 9/11 we had Michael Chertoff at a

key position you know, in charge of criminals, the criminal division of the Department of Justice,

and he is a dual national Israeli American, whose mother was one as the first Mossad agents in the state of Israel, so with those kind of people at the very top, you remember at 9/11 we had a brand new director of the FBI, a brand new director, Mr. Mueller, and he was only on the job for less than a week, and so when I checked into it you know and asked who's making these decisions at the Department of Justice you know, and guiding this investigation, 9/11, I was told it was Michael Chertoff.



DBS:

Well and you know Michael Chertoff was also the gentlemen who went up to upstate New York off and got a pedophile charge sealed on Scott Ritter.

CB:

Right.

DBS

And when you start looking around at this stuff, there it's always the same faces or the people and same group here...

CB:

They keep popping up in there, not you know, they are not tied to the Vatican, they are not tied to the Opus Dei, I mean all of the people I have found are neither Jesuits nor Catholics. The people who are in the key positions that I have found, like Michael Chertoff, like Sam Miller, like Alan Ratner, who was involved in the selling of ...

DBS:

...like Gladine

DBS and CB:

CB:

... they are on the contrary to being Jesuits, they are Zionists, and what we call warm, warm Zionists or warm Jews, that is they are active supporters of the state of Israel, like Sam Miller that I told you about, he is the national chairman of United Jewish Appeal, which is the largest Zionist organization in United States, collecting money and giving support to the state of Israel, and Larry Silverstein, leaseholder of the World Trade Center, was also in a former leadership position at United Jewish Appeal, as was **Louis Eisenberg**, who oversaw the privatization of the World Trade Center, giving it, so what we find, we find Zionists, Jewish Zionists, at every key checkpoint, every key juncture of the 9/11 saga ...

DBS:

...and you'll find you'll find them in our investigative area...

CB:

...Michael Chertoff... Michael Chertoff is a good example, you know we had, according to Michael Cameron, and also articles in American Free Press, going back long before, we find that there were in fact at least two hundred Israeli agents, who had been involved in either eavesdropping, snooping on these 19 Arabs or like the 16 movers who were involved in clearly having driven vans with explosives, with box cutters, and celebrating the collapse of the World Trade Center, videos, what have you, like the five guys arrested in Jersey City. These people were all taken into custody and held, and even you know, given lie detector tests, which they failed, and then though, rather than being you know, sent to Guantanamo or anything like that, they were sent back to Israel at taxpayers expense on simple visa violations, while at the same time Chertoff rounded up like eight hundred Muslim people, and Arabs, and said "here are your terrorist suspects" and it turned out of course, that all of those eight hundred or nine hundred Arabs they rounded up, were all let go,

and they had no involvement in terrorism.

DBS:

Chertoff was also the chief investigator on the first World Trade Center bombing back in 93...

CB:

Exactly, and that's a key point. Chertoff is a, I think he was a district attorney or attorney general in the state of New Jersey.

...like you said he managed and oversaw that legal process that resulted in which these judas goats, these agents, Zionist agents, and people who were paid informants. I think his name was Emad Salam, was the FBI informant, who was central to the entire 93 bombings, he was paid a million dollars by the FBI to be an informant, I mean that's an incredible amount of money to give an Egyptian fellow to you know, to play a role in a fake type bombing scenario, and what I think is that you know, there are books about this kind of thing, but

the 1993 bombing, and the Oklahoma City bombing, which the FBI was very closely involved in both, these were meant to sort of prime the pump for 9/11, so that Americans would get used to the idea that there that terrorism is a fact of life, and is a danger and a threat to them, so that when 9/11 happened, it didn't come out of the blue, they could say well look, we, you know, this is what they finally made good on their threats.

DBS:

That's right...

And I happen to know that there are other connections to this particular group, and the Pentagon of course, I've had Karen Kwiatkowski, Lieutenant Colonel on, she said that Douglas Feith and Scooter Libby and the rest of these, and they are all diehard neocon Zionists and I say neocon Zionists because I want to make the connection to what the mainstream press called them, and what we know them as, the fact is, neocon Zionists were involved in a very important control point of this spy scandal here and within the Pentagon, Larry Franklin, and the spy scandal, and of course these same names came up with the Pollard case ... the point were trying to make here, is that the organs of control, power, and expression, are either the FBI, Pentagon, or Justice Department, and the White House.

And then of course, when you want to look at acquiescing to all these crimes, we can start looking at congress, which has been bought and paid for, and having political pressure made by ADL, Southern Poverty Law, by People for the American Way, all of these organizations, their pressure on congress, to

either turn a blind eye, or to participate ...

CB:

...and when you challenge that, like Senator Paul Wellstone, from Minnesota. When you stand in the way of that bulldozer of the neocons, like he did, you know, he was killed in a very mysterious plane crash in upstate Minnesota, and the FBI agents were apparently on their way to that crash site, before his plane even crashed, they had driven up from the Twin Cities and they were on the way while his plane was still in the air, as if they anticipated his crash.

DBS:

well you know you can take a look at certain spots in the country for their control, Cleveland looks like one of them, Minnesota is another big hotspot for child pornography, child sex slavery as well as political Zionist control ...take a look in the Los Angeles area and take a look at the Miami area, and the New York region...

CB:

Absolutely.

DBS:

... these are the areas of the country that have been peppered with extortion and bribery and all kinds of control; so that they have a good home base to nest themselves in.

CB:

They are in charge of what I call, or some people call, the concentration camp of the mind, and that is the media ... and in New York it's a particularly a tight media you know, screaming at the New Yorkers all kinds of nonsense and half truths and lies ... but in the United States as a whole, the media is largely controlled, Zionist controlled...

There are very few voices like yours that are able to break through the cracks in that establishment, and this is why what we call the fantasy version of 9/11, like this recent film United 93, these voices are the loudest, and this movie you know, now its only four years after 9/11 but the mainstream media is now engaging itself in what the events of 9/11, so we're getting mainstream, what I call the mainstream 9/11 voices, and these mainstream 9/11 voices are being heard in the mainstream media, on CNN for example, but what these mainstream media voices do is they completely ignore the abundance of evidence that points to Israeli involvement in in September eleventh, what they point to instead is that they want to put all the attention on like Bush and Cheney you know, being a political year, they want to put the blame on the White House and say well, you know 9/11 was crafted in the Republican party,

so if we just have a change of party here, and get the democrats in, our troubles will be over...

DBS:

That's right, and you know Eric and I six weeks ago now, when Alex Jones came out with this Charlie Sheen nonsense, we knew right away what this was about, this was going to be a little show, a little show and tell for everybody that Charlie's gonna come out, become a short period hero, be wonderfully received in a lot of communities around the country who are very angry, and then they are going to pull the rug and ruin his credibility, we saw this the day he came out, we wrote an article the following day, and boy if we were not proven absolutely spot on the money.



CB:

Right, right, I think that's what they call a limited hangout type thing, where they let a little bit of the truth come out, and in the case of Charlie Sheen, like you said, they destroy his credibility afterwards.

But this is what's going on with the whole nine eleven movement, they are gonna let a little bit of truth out, in order to entice that huge percentage of population that it is absolutely demanding answers. The United States, as I've been saying for years, is being controlled by a crime-ocracy, and this is the people who you know, they have corrupted our voting system so that we have

no oversight over elections anymore, so this system of fraudulent voting brings into power these criminal networks and that is where the control all begins, and when you have a crime-ocracy in the United States, states, waging illegal wars and allowing mass murder to happen in New York City, without being properly investigated, I don't see how this country can prosper.
